Proposed Constitution/By-law Amendments

# Proposed Change 1 (Constitution)

## Reason for change:

At last year's AGM, fewer than 9 directors were placed on the Board of Directors. The proposed change is procedural in nature and would allow the Board to be made up of "up to" 9 directors without being in contravention of the Constitution.

## Proposed Change 2 (By-laws)

## Reason for change:

The Board of Directors has dealt with an increasing number of incidents recently that constitute breaches of GMHA's Code of Conduct. In order to clarify the process by which the GMHA disciplines its members for such breaches, to inform the entire membership what is at stake, and to confirm its commitment to the Code of Conduct and its enforcement, the following changes are recommended:



## (C) DISCIPLINARY AND/OR SUSPENSION POLICY

5. Any Member, Coach, Player or Game Official may be subject to the following disciplinary actions if found in contravention of the code of conduct:

First Offence: Written warning from the GHMA Executive and proof of the retaking of the Respect in Sport Program Second Offence: Suspension from ALL GMHA activities (games, practices, special events) for a period not less than one (1) week from the date of the offence or the conclusion of an investigation/decision by the GMHA.

Third Offence: Suspension from ALL GMHA activities (games, practices, special events) for a period of not less than six (6) months from the date of the offence or the conclusion of an investigation/decision by the GMHA.

PLEASE NOTE, DEPENDING ON THE SERIOUSNESS OF THE INCIDENT/INFRACTION, INDIVUDUALS MAY BE SUBJECT TO FURTHER PENALTIES IMPOSED BY THE OMHA, HOCKEY CANADA OR LOCAL LAW ENFORCMENT AND FOREFEIT THEIR RIGHT TO PROGRESSIVE DISCIPLINE FROM THE GMHA.

#### **DISCIPLENARY COMMITTEE**

- 1. A chair shall be appointed by the president at the first executive meeting of the season.
- The committee shall include four (4) members. This is to include two (2) members of the Board of Directors and two (2) Directors.

6. Any Member may request in writing the Discipline Committee to rule on an action that took place inside or outside the arena that falls under this area. The Committee shall review the evidence and if necessary hold a meeting with the parties involved and make a ruling.

## **BY-LAW #3**

#### **DISCIPLENARY COMMITTEE**

- A chair shall be appointed by the president at the first executive meeting of the season.
- The committee shall include three (3) members. The three shall include at least two (2) members of the Board of Directors and may include one (1) past/retired Director (example a past President).
